JT Visuals LLC will capture and master the images in digital form, complete with state-of-the-art video editing capability.
  - (2) PAYMENT. (Client). \_\_\_\_\_ agrees to pay JT Visuals LLC, a sum of \$\_\_\_\_\_ in consideration of the videography services to be rendered by JT Visuals LLC. JT Visuals LLC will provide proofs for final purchase of videos. Should Client request JT Visuals LLC to create a compilation or other material from the footage, the fees for this service will be provided to client at that time by JT Visuals LLC. PAYMENT METHODS. JT Visuals LLC will ONLY accept these forms of payment methods. (Invoice only sent to email).
  - (3) DEPOSIT. At the time of signing the Contract, Client shall pay one third of negotiated contract amount up front prior to book slot and hold that date. A non-refundable deposit of one third of contract to JT Visuals LLC for the services. The deposit will be subtracted from the total payment owed by \_\_\_\_\_ upon completion of services remaining two thirds must be paid.
  - (4) CANCELLATION POLICY. All deposit fees are non-refundable. A minimum of 1 notice will be required for cancellation of this contract. Any cancellation made with less than 24 hours' notice prior to the agreed upon service date will result in full payment by client to pay remaining two thirds balance due. Reason for this is the time slot was allocated for and other possible client's bookings were turned away.
  - (5) If the cancellation is initiated by JT Visuals LLC, all monies paid to JT Visuals LLC from the client shall be fully refunded, INCLUDING the deposit fee.
  - (6) Refunds shall be paid out at month's end.
